A special meeting of the Board of the Ontario-Pomona Jewish Center was called to order by Vice President Harry Grossman at 8:30 P.M.

The Board voted to accept the resignation of Al Glusker as President of the Ontario-Pomona Jewish Center.

Mark Weiss moved that Harry Grossman be made president for the balance of the year. Carried.

Harry Grossman explained that we must change our attitude. The by-laws say we should have monthly Board meeting, and four general meeting a year. We have been having general meeting much more often and he suggests that we dispense with these general meeting and only call them once in a while when they are necessary. And once and for all stop name-calling at meetings. After suggestions of several members it was decided to continue with general monthly meeting but to confine them to reports of the Board and cultural activities. At the same time collecting dues and accepting donations.

Important projects to discuss this evening – employing a Rabbi and starting the building. Jack Greenberg was called on to report on the building, and he explained that Harry Grossman and Jack Greenberg had spent several hours with Mr. Anderson the architect that day. The two lowest bids for the building so far were around \$36,380. They went over the plans to determine what we could build with the we know we will have and still have an assembly hall an space for Sunday school rooms. The portion that we could build for \$30,000 would consist of the large assembly hall, the pulpit and a room on either side of the pulpit, kitchen and two lavatories. Both Parker and Richie and rebidding on a brick building and Hanawalt will rebid on a reinforced concrete building.

1947-07-17 Minutes

A Board meeting of the Ontario-Pomona Jewish Center was called to order at 9:15 P.M.by President, Harry Grossman.

For an hour previous to the meeting the Board visited with Rabbi Alex S. Wiesel of Los Angles who heard that we were looking for a Rabbi and came out to apply. He told us of his success with the congregation he just left; he built it up from a membership of 20 to over 200. He will be glad to come out to give us a Friday evening service upon our request.

Rabbi Max Vorspan of St. Louis, Minn. A graduate of the Theological Seminary was recommended very highly by Harry Friedgut as a second Rabbi Pressman. If we wish him to come to Pomona to see us we would have to pay his fare which would amount to about \$200. His salary would be \$6,000 per year.

It was understood we could employ a student Rabbi for the High Holiday services for \$1,000. Other Rabbis who have applied to us are Abraham L. Rosenblum at a salary of \$5,000. Also Rabbi David Cohen from Pasadena. Harry Grossman spoke to Rabbi Cohen who would come here part time for \$3,600 or \$4,500 depending on how many days we wanted him; or full time at \$7500.

Maurice Lasky moved to eliminate all Rabbis except Rabbi Vorspan unless he comes out for an interview at his own expense. Seconded by Mark Weiss. Carried.

Jack Greenberg moved to table the application of Rabbi Cohen until we hear Rabbi Wiesel. Seconded by Maurice Lasky. Carried.

Maurice Lasky volunteered to talk to Mr. Waldman who is president of the congregation where Rabbi Wiesel was employed and find out what he could about the Rabbi. He will also see other members of the congregation whom he knows. Harry Grossman will speak to Mr. Friedgut about him and see if he approves of this Rabbi for us.

Harry Grossman suggests until such time that we employ a Rabbi we table matter of continuing with United Synagogue.

Maurice Lasky reported some time with Architect Anderson about changing position of the building on our present lot. If other parts of the building will not be built Mr. Anderson advises turning the building on the lot. Will the building as now suggested be suitable for Pomona if there will be a split in 7 or 8 years? If we could build closer to Ontario the congregation would probably stay together longer.

Jack Greenberg moved that Maurice Lasky be appointed as a committee of one to see we could buy a lot on San Antonio Ave. Seconded by Ben Swerdloff. Carried.

(Motion missing from minutes.) Jack Greenberg suggested that if we consider this man at all we give him a one year contract and then only one more year.

Harry Grossman brought up the question - - should we even think of employing a Rabbi before we have a building? This Center will break a good man's spirit. Should we wait until we get the new building under construction? Decision by Jack Greenberg and Julius Feingold was to hire a man before we start to build.

Stella Kelber brought up a Sunday school question. She said Rose Katz may take over the job of superintendent of the Sunday school. The question is - - if children join the Sunday school whose parents are not members, should they be charged a fee? This matter will be decided upon at a little later date.

Mark Weiss suggested that the orthodox faction be asked to join the Center and meet for early services thereby contributing to the Center and helping in it's support.

Al Glassman moved to send Rabbi Trepp \$25 to cover railroad fare. Seconded by Julius Feingold. Carried.

Maurice Lasky was asked to purchase 5 dozen paper yarmulka to have at the Center. Stella Kelber is to buy 2 dozen tin cup ask trays. Al Glassman is to get a figure on strengthening the floor and wall of the Center can call Harry Grossman.

Julius Feingold said he would be glad to take care of a Yahrzeit book. If everyone would give him dates he would be glad to call them and make arrangements for Yahrzeit services. This is a very god way to have money coming into the Center treasury. There are many other ways of getting in extra money.

Harry Grossman was unable to report on the Ebell club as a place for our High Holiday services as the woman in charge is on vacation and will be back next Monday.

There being no further business, meeting adjourned at 10:15 P.M.

1947-07-28 Minutes

A Board meeting was called to order at 8:15 P.M. by President Harry Grossman. Minutes of the last meeting were read and approved.

President Grossman stated that the two major issues were for this meeting were the High Holidays and our proposed building.

Mr. Anderson, the architect, presented two bids for the building: \$28,750 from Mr. Richie and \$30,647 from Mr. Parker. These bids do not include asphalt title, painting, electrical fixtures or hardware. Hanawalt Bros. did not bid as they are not interested in building churches as they are very busy at this time.

Maurice Lasky reported the property adjoining San Antonio School could be purchased. These start with the corner of San Antonio and San Francisco is 127 X 60 feet at \$2,000 and adjoining with a 57 foot frontage on San Francisco at \$1600 each, including all improvements. It was suggested that we need the corner lot and two additional lots. He had the idea that 3 or 4 members could purchase the present Orange Grove Ave. lot from the Center so that the Center could buy the new lots on San Antonio. Then when the Orange Grove Ave lot is sold at a profit the Center could benefit.

Stella Kelber said a church is for sale in Ontario on Euclid Avenue and E. Street for \$31,000. Maurice is look into the church in Ontario and also devote his time to the San Antonio properties.

Mark Weiss, Jack Greenberg and Harry Grossman had an opportunity to speak to Rabbi Leo Rep who came to our community last Friday evening. To give us a service. Rabbi sent a letter after spending some time at the Greenberg home. Jack Greenberg recommended that this Rabbi would be his choice if this community could afford \$6,000.

Maurice Lasky investigated Rabbi Wiesel and Rabbi Hahn of L.A. did not recommend him.

The Glick brothers, members of the South West synagogue praised him and said he was a good teacher, and increased their membership. He was employed as an orthodox Rabbi and admitted he did a few unethical things. Mr. Waldman, president of this congregation, said they gave Rabbi Wiesel \$2200 so he could leave before his contract expired. Harry Grossman added that Harry Friedgut reported that he knows the man and he has no credentials and he is notable to satisfy Mr. Friedgut as an ordained Rabbi. Jack Greenberg moved that we invite Rabbi Wiesel out for a Friday evening service and ask him to stay until Sunday to talk to some of the Board members. Seconded by Mark Weiss, carried. Jack Greenberg suggested that if we consider this man at all we give him a one year contract and then only one more year.

Harry Grossman brought up the question – should we even think of employing a Rabbi before we have a building? This Center will break a good man's spirit. A Board meeting of the Ontario-Pomona Jewish Center was called to order at 8:35 P.M. by President Harry Grossman.

Harry Grossman introduced Student Rabbi Paul Dubin who was recommended by Harry Friedgut for High Holiday services. Paul Dubin is 23 years of age, a UCLA graduate and has completed one year of the Theological Seminary in New York besides previous Hebrew training in Los Angeles. Nearly an hour was spend in pleasant discussion, Questions and answers. Two points made Paul Dubin would like ushers should seat members to keep order and quiet and services would start and end on time. The fee would be \$500 for the services plus lodging and food.

Jack Greenberg moved we employ Paul Dubin for High Holiday services for \$500. Seconded by Maurice Lasky and carried.

The Ebell Club will be available for High Holiday services if we can get the o.k. from Bishop Reeves of the Mormon Church to make arrangements to hold their Sunday evening services elsewhere so that we may have one Sunday evening. Harry Grossman will have a definite answer in a few days.

Maurice Lasky reported that plans would be revised if necessary if we decide to purchase the lots on San Antonio Ave. However, nothing further to report at this time.

Harry Grossman, Sam Kelber, and Maurice Lasky looked at the church on the corner of E Street and Euclid Ave in Ontario, which is for sale at \$31,000. This is a red brick building about 35 years old and seats 200. This can be expanded by 100 seats by raising doors of adjoining hall. The roof can be repaired for \$250 (Hoyt Lumber Co.). The building is impressed them and as Harry Grossman says, "If we purchase this church we can get into business quickly." If we purchase this church High Holiday services can be held there. The Board members are to meet Thursday evening at 8:00 o'clock to look at this church.

Maurice Lasky brought information on a Memorial Tablet, however, this will be discussed further at a later date when we have a building.

Maurice Lasky suggested having a rabbi come for a Friday night service for the entire community. Harry Grossman is to invite Rabbi Werner to Pomona to conduct a Friday evening service on July 11. The community will be notified. The Board recommended offering a Rabbi a contract for one year.

The Board will ask for authority to put the present building up for sale, at the next general meeting, July 15th.

High Holiday services were discussed and Mark Weiss, the Religious chairman, will be in charge of these services. Harry Grossman will look into the Ebell club and K of P Hall as suitable places to hold our Holiday services this year.

Ben Swerdloff suggested that the Sisterhood serve refreshments at general meetings which met with the approval of the entire Board. Stella Kelber, Sisterhood president, will be contacted.

Harry Grossman suggested having a picnic. This will be planned to hold after we employ a Rabbi.

The meeting adjourned at 11:10 P.M.

General Meeting of the Jewish Center Congregation and all members of the Valley's Jewry was called to order at 8:50 P.M. by President Harry Grossman. Minutes of previous meetings were read and accepted.

A question on charging for Holiday seats was brought up and it was stated that seats will be \$7.50 per seat per adult.

The United Synagogue is putting out a diary telling about the holidays, etc. to sell for 40 cents per single copy or 35 cents in lots of 50 or more. It was decided that anyone wishing to purchase one of these diary's should order individually.

The President appointed a Nominating Committee to get busy on candidates to be elected on the Board of Trustees this year. The new committee – Mark Weiss, Chairman, Ted Blumenfeld,

Al Chavin, Irving Goldman and Ben Swerdloff.

The main purpose of this meeting concerns the purchase of a church in Ontario. Jack Greenberg, Chairman of the Building Committee was asked to tell the price of the property, value of the property from an investment standpoint, condition of the building and rooms available. After a full explanation Jack Greenberg recommended that this property be purchased by us. Mark Weiss, Chairman of the Religious Committee, told the Church's availability for religious purposes. Isabelle Weiss reported on its social aspects. Ben Swerdloff reported as to its facilities for lodges. Church lot 62' X 135'; vacant lot next door 31'X135' priced at \$13,500.

Good points brought forth:

pride of location; additional members if in Ontario;

holiday services in our own building tis September;

immediate possession would strengthen our congregation;

would employ a Rabbi immediately;

we would be buying a Temple proper, assembly hall, class rooms and place where lodges could meet:

could make money when we would want to dispose of it; cost \$32,500 (additional \$1000 for incidentals) as compared to \$36,000 to build a Temple.

Bad points: Majority of members live in Pomona.

Harry Grossman said that everyone can speak and discussions were to be limited to 2 minutes. Now was the time to speak or forever hold your peace. Considerable discussion followed.

Item brought up: Finances for purchase: \$7,000 cash on hand

\$4,000 to \$5,000 collectable pledges. \$3,000 additional from Ontario people

\$4,000 sale of present lot.

Someday each town will be able to support a Temple of its own. Trustees will work out an agreement satisfactory to both residents for the return of all moneys advanced.

Julius Title moved to give the Board of Trustees authority to negotiate the best possible deal for the purpose of purchasing the Church property in Ontario. Kibby Zatinsky seconded the motion. Motion carried 27 to 9. Jack Krawll and Sal Rosenthal were tellers.

Harry Grossman urged all members to pay their pledges now. Jack Greenberg asked for the money from the ad program, please. Committees will get to work immediately.

Mark Weiss moved that in effect we buy the building in Ontario and the Trustees have authority to sell the lots on Orange Grove Avenue. Julius Feingold seconded the motion and it carried.

The meeting adjourned at 10:40 P.M.

High Holiday Services will be held at the Ebell clubhouse They want \$135 for the use of the hall. Jack Greenberg moved to proceed to engage the hall for \$135. Al Glassman seconded the motion. Carried.

We visited the church on 5th St and Thomas in Pomona. This church is for sale at \$35,000. Jack Greenberg gave his opinion on the property He had two objections. 1. The traffic on 5th St. and noise of trucks and 2. The present owners would use the church with us for one year. Sal Rosenthal was asked to make further inquiries. Jack Greenberg will handle all matters pertaining to this sale.

Harry Friedgut advised our president of a Rabbi Halevy, formerly of Pasadena and now of Ventura, is looking for a new pulpit and would like to come out to see us. It was decided to wait until after the holidays and then invite him out.

Harry Grossman read a letter he prepared to send out to the community about Holiday services and ticket sales. Mark Weiss is in charge of ticket sale with the help of Al Glassman in Pomona and San Selk in Ontario. Paul Dubin, who will officiate at our services expressed a desire that each member have his own seat and that we have ushers. Mark Weiss will also take care of ushers.

Stella Kelber advised the Board that Mrs. Siler of the Trinity Church in Pomona would like a speaker for Sunday morning. A young man or woman to speak on Judaism and qualified to answer questions. This is for a married group. For the last four years the church has interfaith services and invited a minister from different faiths to speak. Discussion on a possible speaker followed.

No statements have been sent as yet to members for this year's dues. It is the consensus of opinion that no invoices will be mailed to members until we buy a building and employ a Rabbi.

The question arose – should we turn away anyone who can't afford tickets. Some members felt that no one was in that position. However, the ticket sellers were advised to use their own good judgement.

Congregation Meeting: President Harry Grossman opened the meeting at 8:50 P.M. Mr. Harry Friedgut and Rabbi Wytholer of Highland Park were introduced. Rabbi Wytholer gave the invocation.

Newcomers to our community were introduced: Mr. & Mrs. Wolfe, Mr. & Mrs. M. Rabin, Mr. & Mrs. J.C. Weinberg and son, Mr. & Mrs. S.L. Brier, Mrs. Drebin, Mrs. Fried, Mr. & Mrs. Gotluss and thee Garber Brothers.

Jack Greenberg gave a Building committee report. There is a bank balance of \$7,206.76. Jack is not in favor of purchasing property on San Antonio Ave. The plans have been revamped, and the amount of floor space cut down and a different type of structure to be erected. Under the revised plans an assembly hall, Sunday school class rooms and kitchen make a total of 27,000 sq. costing \$25,000. The Temple proper of 3,000 sq. feet will be built at some future time. An artist drawing of the new plans was shown.

Julius Feingold moved that the Trustees be given authority to erect a building on the Orange Grove property at a cost of \$20,000 to \$25,000. There was very little discussion and the motion passed unanimously. We are hopeful that construction can started in a month.

Jack Greenberg moved that the Trustees place the present building on the market, subject to possession when our new building is ready for occupancy. Loretta Zatinsky seconded the motion and it passed.

The Nomination Committee recommended Sam Selk, Ben Tarshish, Julius Feingold, Mark Schwartz, and Loretta Zatinsky. Al Chavin's name was added from the floor. Mark Weiss moved that nominations be closed, seconded by Reta Grossman, and motion carried. Those elected were Mark Schwartz with 32 votes, Ben Tarshish with 31 votes, Loretta Zatinsky with 30 votes and Sam Selk with 29 votes. Sam Selk will have a two year term to fill the vacancy caused by the resignation of Mr. Glusker. Our Board now consists of Harry Grossman, Jack Greenberg and Ben Swerdloff whose terms expire October 1948; Esther Grossman, M. Lasky, and Sam Selk whose terms expire October 1949; Mark Schwartz, Ben Tarshish and Loretta Zatinsky whose terms expire October 1950.

Reta Grossman moved that we dispense with reading of the minutes as they were not read at the proper time. Seconded and passed.

The meeting was turned over to Mr. Friedgut who complimented us on our meeting tonight. He said it was a very stimulating to him as the last meeting he attended was rather stormy. He introduced Rabbi Wytholer who gave a very interesting talk on the necessity for studying Judaism. That through the knowledge of our religion we gain strength to carry on Without this strength Judaism will perish. Mr. Friedgut made a plea that we raise \$611 for the Seminary. That we should send this money in, in honor of Paul Dubin who officiated at the Holy Day services this year.

It was moved to pay a tuition scholarship of \$611. Petition the U.J.A. for \$400 and raise the balance ourselves. Seconded by Mark Weiss. There was an amendment that we pledge ourselves to raise this money. Amendment was passed.

Meeting adjourned at 11:35 P.M.

Mr. Meyers gave a short talk. He reminded us that we know well the work of the Seminary. The Eternal Light program on the radio is one of their projects as well as the rabbinical school. He stressed the need of a large membership and that he may be able to have Mr. Dor Sheri, producer of the picture "Crossfire" as a guest speaker at the membership banquet. Mr. Meyers also suggested having one of the recordings of the Eternal Light program as a feature for the banquet. It was suggested by Mr. Meyers that we place the amount of \$611 that we are to raise for the Seminary on our community Fund Drive.

Mr. J. Greenberg made a motion that we sell our present building to Mr. Shapiro for \$5,000. Seconded by Loretta Zatinsky. Motion carried. A cashier's check for \$500 accompanied the offer.

Jack Greenberg spoke on the need of every one paying up on their pledges as our building is going up and the contractor will be presenting his bills soon.

Jake Greenberg moved that we apply the \$5,000 from the sale of the building as soon as possible to reduce the mortgage. Seconded by Mark Weiss, motion carried.

Reta Grossman moved that we employ Mr. Collins to take over the books of the congregation. Carl Zatinsky seconded the motion. Motion carried.

President Harry Grossman stated that he and Mr. Tarshish have undertaken to investigate the matter of a cemetery. The Pomona Cemetery has 20 acres that is undeveloped and would be

glad to let us have 5 acres. They would improve a small area of about 50 graves for \$50. The graves would cost the Congregation about \$75 or \$80 and could be sold for \$150 per grave. This price would include perpetual care of the graves; the Rabbi has investigated Blackman's mortuary and finds that there is nothing to keep us from using this establishment.

Once again we hope for the last time the question of children attending our Sunday school and Hebrew School who are not members was made clear. Children whose parents are not members will be accepted for a fee of \$36 per year. In cases where finances do not permit payment of their sum, if such a person will see President Grossman, arrangement will be made to accept the child or children.

Jack Greenberg volunteered to raise is dues for the year 1947 and 1948 from \$36 to \$250. Carl Zatinsky added \$100 to his dues, making his dues \$136. Mark Schwartz added \$36 to his dues making his membership dues \$72. Essie rank raised her dues to \$50. Ann Morton raised her dues to \$75. Harry Grossman added \$100 to his dues making it \$200. Dr. Langsner added \$14 to what he has already paid.

Rabbi Dolgin is willing to help out on the membership drive.

Congregational meeting of Beth Israel Congregation was called to order at 8:55 P.M. by President Harry Grossman. The minutes of the April 4th Board meeting and April 7th Congregational meeting were read and approved.

Harry Grossman: The proceeds of the old building are being applied on the mortgage of the new building and that we all felt pretty certain that sufficient funds would come in so that we could pay our bills but money has not come in. Our Building committee tells us that we need about \$3,000 immediately. Bills to be paid now are \$1,400 for the sliding doors; \$625 painting; \$272 due Mr. Anderson for supervision of building; extra on the building not contracted for \$137. A bill has not yet been turned in from Sam Selk for the floors but will be approximately \$600 – Sam Selk's cost.

We were informed at this time that the United Jewish Appeal Committee has allocated 10% of the amount raised on this drive to the building and Center. This news we all enjoyed hearing.

Harry Grossman ask to please give Jack Greenberg a round of applause for the splendid work he has done for our building. Sam Selk ask for the same appreciation for Harry Grossman.

Sam Selk also told us the good news that a velvet carpet is being donated for the pulpit by San Selk of Ontario.

Mark Weiss gave Harry Grossman a check for \$500 as a donation to the building that we purchase chairs so vitally needed. He is fully in accord, however, of the suggestion of Harry Grossman to sell seats to members for \$10 each in order to raise additional funds. Harry Grossman and Jack Greenberg saw some metal folding chairs which sell retail for \$6.30 each and which we will be able to purchase through a dealer at the dealer's cost of 30% discount making the price \$4.50 each. These will be purchased.

A number of men have been thinking of a Men's Club for our Temple. Our President has asked Dave Kantor to assume chairmanship to organize this club. This will be strictly a social

club but still have one project a year to raise money for the Temple. This should bring in many people who may not be interested in other offerings of the Temple.

Our president leaves Wednesday morning on a business trip and he informed us and particularly Loretta Zatinsky- that while in the East he will see if he can find a suitable Eternal Light for the pulpit. Loretta Zatinsky expressed a wish some time ago to donate this light.

1Loretta Zatinsky volunteered to purchase one dozen tin cups to be used as ash trays.

Isabell Weiss was authorized to make arrangements with the cleaning woman to keep our building clean and the price not to exceed \$15 per month.

The Sisterhood was asked to arrange to have flowers every Friday night for the altar.

Jack Greenberg reported that he had four ads for our bulletin. He asked for a co-chairman for Ontario. Sam Kelber volunteered to take care of this.

Tables: the cost of tables needed will be \$200. The number of tables and sizes are all figured out. Harry Grossman had a sample table made at the Bestile shop and that table is in our building now. The men will get together and make the rest of these tables.

The colored movies taken by Peggy Greenberg of the Ground Breaking and Cornerstone Laying will be shown at the next Congregational meeting.

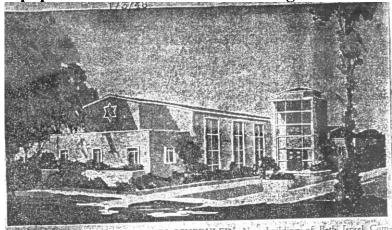

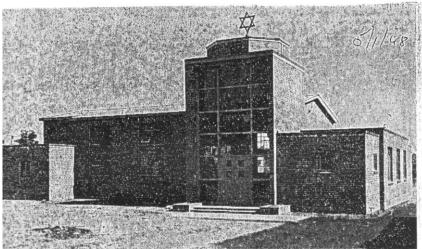

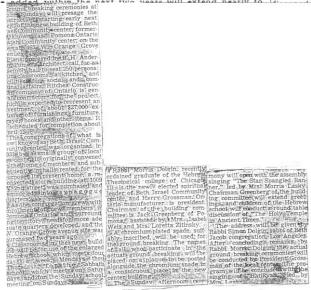
